This is an opportunity for all photographers to submit images for a show which will hang in our Cherry Creek North gallery for the month of JULY, 2008 and will be listed on our web site. This show has no required theme and both Traditional & Digital work will be accepted.

**Judging & Conditions:** Primary criteria will be the Artistic Merit of the Image but Quality Execution of Print and Presentation will be taken into account as well. Photographs will be judged on submitted work, which must be matted, framed and wired - ready to hang. All images must be available for sale; price to be specified by entrant. Gallery to retain 50% of sales price. Maximum frame size: 20"x24". Smaller sizes invited! All images must be clearly marked with photographer's name and not entered into one of our previous competitions.

**Ribbon Categories:** Black & White  
Color  
Alternative Process or Presentation  
(Collage, Hand Colored, Bromoil, Palladium, Platinum, Narration, etc.)

1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and Honorable Mention Ribbons will be awarded in each Category with at least 5 submissions. There will be no separate "Digital" Category.

**Entry Fees:** \$25 for one image; \$35 for two or three images  
(3 image maximum)

**Liability:** Gallery will take all reasonable care to protect & maintain all submitted work in its original condition but can assume no liability beyond that of reasonable care.
